

General Rules and Regulations

- All stands strictly accommodate a maximum of six (6) persons. This includes adults, children
 and toddlers of all ages.
- Only one (1) caravan/motor home and one (1) tent are allowed per stand. No occupant will be allowed on the premises without a proper caravan/motor home or tent.
- One vehicle and one (1) boat per site is permitted. Additional vehicles and boats will be charged at an additional rate.
- A maximum of five (5) day visitors to a camper travelling in one vehicle are allowed per day, per site at additional costs per person payable on arrival. Kindly confirm our rates in office.
- Check in time is from 12:00 on date of arrival and check out time is strictly by 11:00 on the
 date of departure.
- Occupants of the Big Fish Caravan Park are obliged to keep the accommodation in a clean, tidy
 and hygienic condition. No littering will be tolerated.
- All occupants and day visitors to a camper are requested to use all resort facilities and treat
 all property on the Resort in such a manner that will not cause damage. Any occupants and / or
 day visitors to a camper damaging any part of the accommodation, movables or facilities
 on the Resort; whether willfully, negligently or accidentally, shall be held liable for the cost
 of repair.
- All personal property brought onto the property known as Big Fish Caravan Park, is done so at the sole risk of the occupant or day visitor. The occupant or day visitor will have no claim whatsoever for any loss suffered, however arising.
- No loud music or foul language will be tolerated. STRICTLY: No Music after 10:00pm.
- Any disorderly behavior will lead to eviction from the property. Any/all disciplinary decisions
 made by Big Fish Caravan Park Management will be final.
- Please do not collect or remove any wood from the Bia Fish Caravan Park or Farm.
- No fires are allowed to be lit outside of the demarcated bragi areas or on the river bank.
- No vehicles, tents or fires are permitted on the river banks.
- Occupants are reminded that any gates and fences encountered during the course of walks
 mark the boundaries of the resort. Please keep in mind that the property beyond these
 gates/fences is strictly off limits. Please note that fences beyond the camping sites are
 electrified for farming activities.
- The speed limit throughout the entire Resort is idling speed or strictly 10 km per hour.
 Occupants and day visitors found to be in contravention of this rule will be fined R2000-00.
- All boats and trailers must be registered for the Gamtoos River. Boats and trailers must be removed from the launching area or slipway. Boats not in use must be securely anchored or moored.
- Use of these facilities are strictly at <u>own risk</u>. By using/utilizing these facilities you herewith
 acknowledge and agree to indemnify, and hold harmless the Owner and it's officers and
 employees, from and against claims based upon the use of the property and or facilities and
 against Owner's comparative and/or contributory negligence or fault, sole negligence, or
 intentional misconduct directly or indirectly arising against the use of any facilities.
